RESULTS OF 2020 ANNUAL GENERAL MEETING

Pursuant to ASX Listing Rule 3.13.2, the company advises the following in respect to resolutions contained in the Notice of Meeting dated 21 October 2020 and put to shareholders at the Company's 2020 Annual General Meeting held today.

Resolutions 1 to 4 were carried by the required majority following a poll and Resolution 5 was not carried.

The results show a 38.04% vote against the remuneration report and means the Company has recorded its second strike. A Spill Resolution put to the meeting, being Resolution 5, is not carried as this Resolution did not receive the required majority following the poll.

In accordance with Section 251AA91) of the Corporations Act, a schedule of valid proxies received for the meeting is set out in the attached proxy summary.
